Sample documentation used by SNR staff

Daily documentation is a requirement for SNR staff, and it is a part of the service we provide to educators. As a team, you can decide how often you want to receive your documentation – daily, weekly, bi-weekly, etc.

Inclusion Facilitators complete a daily Strengths and Goals Log. This is a strengthbased recommendation/strategy linked first to the ISP, then to any other meaningful observations. At the end of the service level, Inclusion Facilitators complete an ECS Discharge Summary which summarizes the main strategies previously given, and makes recommendations to transition to increased independence with confidence.

Resource Consultants complete a LCCP Consultation at every visit. This reflects the details of the visit which may include updates on children on the Resource Consultant's caseload, referrals, discussions with educators, and plans for success. The Resource Consultant also collaborates with the team to set goals for each child, at minimum, every 3 months. We call this an Individual Program Plan, but it is most commonly called an Individual Support Plan in the community. # The Role of the Inclusion Facilitator

Having an Inclusion Facilitator in your classroom is an opportunity to collaborate and strategize in real time those situations that present as barriers to inclusion. An Inclusion Facilitator is a time-limited resource placed to assist educators in skillbuilding, working alongside you as a co-learner to enhance classroom routines and build confidence. Inclusion Facilitators offer contributions that include modelling, resources, and recommendations to support a fully inclusive classroom. Take this opportunity to ask questions and communicate the classroom needs - don't be shy! Good daily conversation and communication is the key to success.
